From the President



Dear friends and colleagues,

I wish you all a peaceful and prosperous 2016. At this time every year we reflect on what we achieved in the past year and what we aspire to do in the coming one. In 2015 we had one of the most successful congresses both scientifically and financially. European accreditation was completed in 3 burns centres following the Hannover Burns Centre site visit in October 2015. The requirements for self-assessment and the site visit are fully detailed on the EBA website. Sadly, we will remember 2015 for the major burn disaster in Bucharest that has taken the lives of many young people. This disaster has shown the importance

of early cross border transfers.

As the European Burns community, we are starting 2016 with a determination to move closer towards achieving agreed organisational standards that improve care across Europe. In this newsletter there is a summary of panel discussions on certification standards for burns centre accreditation (page 4) that was held at the EBA congress in Hannover. The discussion highlighted the need for a realistic set of guidelines that are applicable across Europe and also a limited data set to support the accreditation system and help benchmarking. This is better achieved by working together with other organisations such as the ISBI and the WHO.

Dr Nadia Depetris, of Turin, Italy is inviting all burns centre to participate in an online survey (page 2) to assess the organisational standards across Europe. I would urge all burns centres to participate in this survey to help mapping out burn care and be able to set realistic required standards.

Summary session: Certification Standards for Burns Centre Accreditation - Panel Discussion

Saturday 19/09/2015

Panel Members gave short presentations on the topics and then an open discussion with the attendees followed. The discussion included care standards, minimal dataset (outcome reporting) and accreditation

1. Care Standards

European, German, US, Italian and UK care standards were presented. There was variation from each country in infrastructure, staffing, service specifications and outcomes.

Discussion Points

- Care standards could range from being aspirational to achievable and both the panel members and the floor have agreed that the European care standards should be to some extent, aspirational, but this should be achievable by most of the member countries. Europe has both high and medium income countries and some European countries have limited resources.
- Burn care has different funding streams in different countries and whilst this is totally government funded in the UK, Spain and Italy, insurance is a major player in France and Germany. Care standards may need to accommodate these funding streams and insure that high quality care provided should not be compromised by profit minded health care systems.
- Both the panel and the attendees agreed that Dr Depetris would circulate, via the EBA secretariat a survey to map out the existing standards in different parts of Europe. The outcome of this survey will allow the EBA standards committee to define a European Care Standard that is both aspiration and achievable across all European countries.

2. Minimal Dataset

Well-established databases in Germany, UK, Spain, Netherlands and the US were discussed as well as the minimal dataset of the ISBI and the WHO. The above datasets vary from 50 to > 500 fields. Defining the dataset and software design will have an initial cost, however the main costs relate to the manpower of the data entry.

Discussion Points

- There was a consensus that the European minimal dataset should include, epidemiological and outcome reporting fields.
- The minimal should be approximately 50 fields.
- Minimal dataset of the ISBI and the WHO, who are very similar, could be used as the European minimal dataset.
- Ownership of the data; the data should be owned by the EBA (the server of the database should probably be based in Europe). Individual units should have the right to access the data for benchmarking and research.
- Privacy policy; All data must be entered anonymously, however this is challenging in burn injury as it is a rare disease and therefore a balance should be struck between anonymously and using the data for benchmarking or as an audit tool.

3. Accreditation

Self-assessment forms and peer review visits have already started in 2015. Burns centres in Zurich and Lausanne were successfully verified. There are plans for a peer review visit in Hannover, Germany in October 2015 for issuing an accreditation certificate.

Conclusion

There was a consensus at the end of the session that a European survey should be performed and also discussion with the ISBI and WHO regarding the utilisation of the minimal dataset.

The Emergency Management of Severe Burns (EMSB) course provides burn specific trauma management guidelines, which are additive and complimentary to those taught on other trauma courses eg ATLS. EMSB is a "stand alone" one-day course that covers the principles of the emergency management of severe burns in the British Isles including practical exercises in burn size assessment, fluid resuscitation, airway and wound management, paediatric burn care, electrical and chemical injuries and simulated cases.

The course is appropriate for medical and nursing practitioners who may be required to provide initial management to patients with severe burn injuries e.g. those working anywhere in the field of burn care, anaesthesia, trauma, pre-hospital and emergency medicine.
