## From the President

Dear friends and colleagues,



It is a great honor to become the EBA president for the next two years (2017-2019).

Our Association faces important challenges that need to be addressed during this period.

More than ever, in a multicultural and united Europe, we must work together to strengthen the Association and the programs that our past presidents (Gerard Beerthuizen, Peter Vogt, and Naiem Moiemmen) have developed. In order to produce continuity for our Association and in the spirit of the European Burn Institute devised by Dr Beerthuizen we have made the necessary amendments to co-opt our last two past presidents

# Guidelines committee

## EBA guidelines 2017

The EBA guidelines 2017 are now available and downloadable as PDF file from the EBA website. They aim at assisting professionals who provide care to severe burns, from the time of injury to wound closure and full reintegration of burn patients to everyday life.

EBA guidelines address caregivers at all the different levels, from non-burn specialists taking care of the early management of burn patients in the prehospital settings to highly specialised personnel in Burn Centres. Moreover, they engage the various competencies of the several disciplines involved in the treatment of such severe and complex patients.

The diffusion and implementation of evidence-based guidelines into the clinical settings are among the key cornerstones for reaching a coherent clinical strategy, ensuring a uniformly high level of treatment across Europe and minimising the healthcare expenditure.

The present guideline should be viewed as an educational aid to improve and standardise the care of the severe burns across Europe and beyond. A multidisciplinary approach, the implementation of locally adapted treatment algorithms and the adherence to evidence-based guidance are the key to improve the quality of the treatment after severe burn injury.

### Starting point

The appropriate management of the burn patients remains a major challenge. On one side, there is still a lack of high-quality evidence in burn care (1), partially explained by the relative scarcity of severe burn case and their clinical heterogeneity. On the other side, the need for a straightforward, clear and actionable language in burn care clinical practice is urgent (2,3).

### The development process of the EBA guidelines

The EBA guidelines were developed by a multidisciplinary team, including surgeons, intensivists, anesthesiologists and professionals allied to medicine all around Europe.

The team members took into account the fundamental principles of the guideline developing methods (4–7), identifying the main clinical questions, searching for evidence and making judgements and recommendations using a consensus process among the team and finally sharing them with the European burn care community.

1. Identification of the main clinical questions  
The starting point for the identification of the key clinical topics and the main clinical questions was the synthesis of the current evidence in the field of burn care, as stated in previous released international burn care guidelines (8–11). The critical appraisal of those guidelines was realised following the AGREE method, under the supervision of methodological advisers. This work provided the basis for the further recommendations' development.
2. Literature search  
Literature searches were performed using the indexed online database MEDLINE/PubMed, supplemented by the screening of reference lists of relevant publications. The aim of each search was to identify randomised controlled trials (RCTs), non-RCTs and systematic reviews that addressed specific scientific questions. In the absence of high-quality scientific support, case reports, observational studies and case-control studies were also considered. Limitations of the search results included "humans" and "English language". The period was limited to 5 years if the query was considered in the previous burn care guidelines; for new queries, the period was limited to 5 to 10 years depending on the number of abstracts identified by each search. Abstracts identified were screened by the authors and, if considered relevant, full publications were evaluated.
3. Formulation of the recommendations  
In writing the recommendations the team adopted:
  - "we recommend" for strong recommendations
  - "we suggest" for weak recommendations.

Strong recommendations reflect the group's high confidence that the benefits of the proposed action outweigh the undesirable consequences (regarding mortality, morbidity, patients reported outcomes or costs) according to the available evidence.

Weak recommendations express the group's judgment that, even though available evidence about the topic is insufficient to strongly recommend a particular action, the proposed action is at the moment supported by the current clinical practice and the expert opinions.

### **The recommendations**

The guidelines, presented to a broad audience at the EBA congress 2017 in special sessions, cover the different aspects of burn care, fulfilling the need for updated recommendations in crucial topics, such as burn shock management, dressing of burn wounds, psychological support and occupational therapy.

### **Next steps**

- Publication and dissemination of the EBA guidelines will be realised by publication on specialised medical journals, presentations at scientific congresses and endorsement by other medical Societies
- Translation of EBA guidelines in European languages and implementation through local protocols will be encouraged and supported by EBA, calling for action the members of different national realities
- A scheduled review of the guidelines will be accomplished every 2 years by a designated EBA multidisciplinary team. The team will adapt the previously released recommendations to new scientific evidence if indicated and address further uncovered clinical areas.
